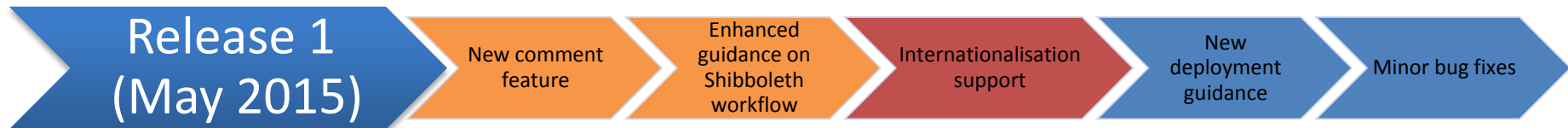

New Features

The new features included in this release of DMPonline are listed in the table below:

Feature	Theme	Description
Plan comments	Usability improvements	Feature to enable those collaborating on the creation of a data management plan (DMP) to attach comments to parts of the plan in order to share ideas and feedback whilst drafting the plan. Plan owners, co-owners, reviewers and others can make comments and attach these to individual answers in the plan.
Shibboleth Guidance	Usability improvements	Improvements to the presentation and textual guidance on the user sign-in form to clarify the process for registration using Shibboleth credentials.
Internationalisation Support	Local-aware Support	Feature to support foreign language versions of the DMPonline tool, where users will be able to switch between selected languages. Only English and Spanish will be available in the near future; other languages will be added in due course.
Deployment User Guide	Active Maintenance	Improved step-by-step user guides with examples of initialisation files to facilitate those users wishing to deploy and host their own instances of the DMPonline tool.

All of the features planned for this release are included in the delivery.

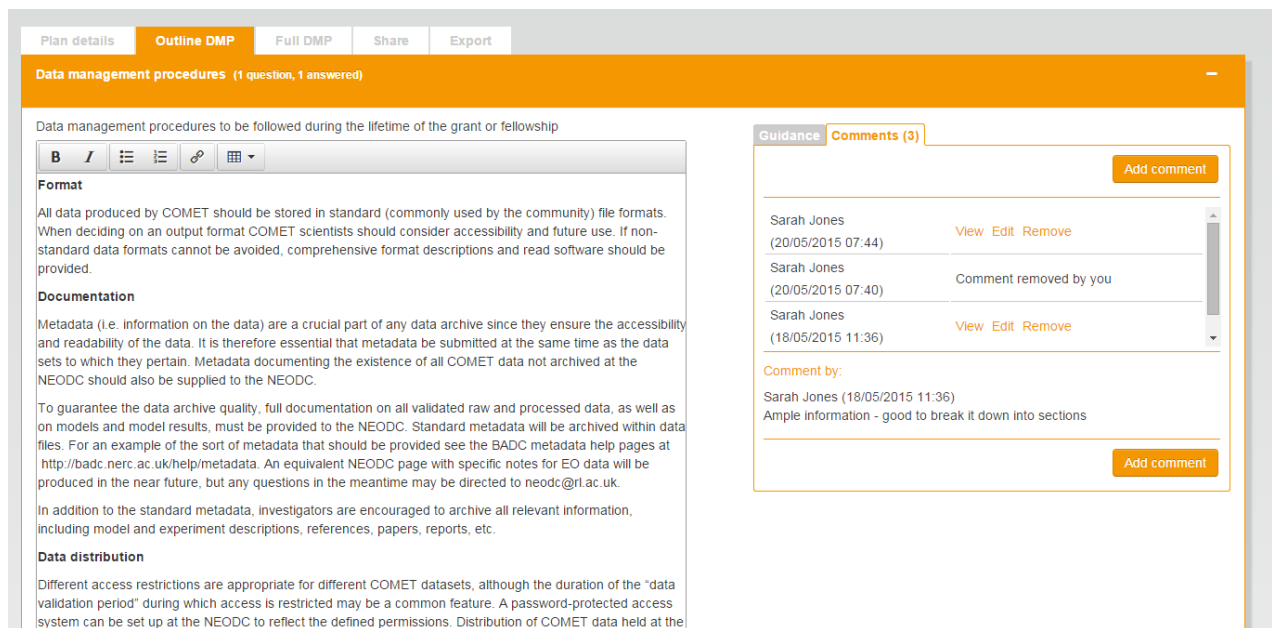
Feature Overview – Plan Comments

This feature enables plan owners, co-owners, reviewers and others to attach comments to individual questions/answers in a data management plan (DMP). Our aim is to enable those collaborating on the creation of a data management plan (DMP) to share ideas and feedback whilst drafting the plan.

For example, reviewers could use this comment feature to provide feedback to those involved in drafting the DMP. Plan owners, co-owners and others could use the comment feature to exchange ideas whilst formulating their answers to each of the questions posed by the selected DMP template.

User Interface for commenting on plans

To use the comment feature, select the *Comments* tab that is presented alongside each question in your DMP as shown in the screenshot below. Note that you can switch between *Comments* and *Guidance* by selecting the appropriate tab.

You can scroll through the set of comments made on each question/answer using the scrollbar. Click on the link next to an individual comment to view, edit or remove the comment as required.

Who can add, edit, view and remove comments?

To promote effective use of comments across the various roles that a user can play during the creation of a DMP, we apply the following rules:

- All users with access to a given DMP may add comments to that plan;
- All users with access to a given DMP may view all comments on that plan;
- Only the user who added a comment may subsequently edit the comment;
- A user may remove any of the comments he/she added to a plan;
- Plan owners and co-owners may also remove any of the comments added to a plan including those made by other users;

These rules are summarized in the table below:

Feature Overview – Shibboleth Guidance

The release also includes both some user interface improvements and a step-by-step user guide to simplify the workflow required for UK users to linking institutional credentials (Shibboleth credentials) to a DMPonline account. These improvements have been carried out in response to the feedback provided by both our DMPonline user group, and a number of UK users.

The step-by-step guide is published as a technical note that includes screenshots to guide users through the tasks of

- Creating a DMPonline account and linking it to your institutional credentials;
- Linking your credentials to an existing DMPonline account;
- Signing into DMPonline using your institutional credentials;
- Unlinking your institutional credentials from your DMPonline account.

Feature Overview – Internationalisation Support

DMPonline is increasingly being used to support data management planning by users at work in different national contexts. To prepare DMPonline for the delivery of locale-aware services, this release includes a technical note that scopes out the functionality required to support localisation in DMPonline version 4. In particular, we propose:

- The range of features to be configured in order to tailor the DMPonline service to any specific locale;
- The mechanism by which users can select their required locale when using the DMPonline service;
- The technical platforms that will be used to develop localisation support within the DMPonline software code base.

The technical note is titled ‘Developing Locale-Aware Support for DMPonline version 4’, and is available via the *Roadmap* webpage (<https://dmponline.dcc.ac.uk/roadmap>)

Feature Overview – Deployment User Guide

We have conducted an evaluation of our guidance for deploying DMPonline in collaboration with a selected set of users, notably the Software Sustainability Institute. The feedback and advice received from this evaluation will be reworked into a step-by-step deployment guide to be published in due course via the wiki on our DMPonline GitHub at github.com/DigitalCurationCentre/DMPonline_v4.

Bug Fixes

The bug fixes included in this release of DMPonline are listed in the table below:

Issue	Theme	Description
Saving guidance text	Active Maintenance	Guidance text was not saving correctly when administrators were creating questions for a template – this is now fixed.
Saving default text	Active Maintenance	Default text was not saving correctly when administrators were creating questions for a template – this is now fixed.
Comment field for multiple-choice questions	Active Maintenance	The comment field was not being displayed under questions that required multiple-choice answers – this is now fixed.
Progress bar for multiple-choice questions	Active Maintenance	The progress bar was not being updated to register that answers to multiple-choice questions had been saved – this is now fixed.
HTML tags being displayed in default answer text fields	Active Maintenance	Some HTML tags were being displayed in text fields when default answers were being used for questions - this is now fixed.
